Statement of Intent

Park Way Primary School is committed to the continuous raising of achievement of all our pupils. Regular attendance is critical if our pupils are to be successful and benefit from the opportunities presented to them.

One of our basic principles is to celebrate success. Good attendance is fundamental to a successful and fulfilling school experience. We actively promote 100% attendance for all our pupils and we use a variety of weekly, termly and annual awards to promote good attendance and punctuality.

The Governors, Head Teacher and Staff in partnership with parents have a duty to promote full attendance at Park Way Primary School.

Parental Responsibility

Parents have a legal duty to ensure that their child(ren) attend school regularly and arrive on time. Regular attendance is essential to the all round development of the child and they should be allowed to take full advantage of educational opportunities available to them by law. Poor attendance undermines their education and sometimes, puts pupils at risk, encouraging anti-social behaviour.

It is the parents' responsibility to contact the school on the first day their child is absent. This is a safeguarding issue so that all parties know that your child is safe.

Pupils are expected to arrive by 8.55am. All children that arrive late must report, with their parent to the community room where the reason for lateness is recorded.

Children must not be left at school before 8:45am as there is no supervision on the playground. In cases where this happens the child will be cared for in the school breakfast club and the parent will then be invoiced for this childcare at the usual breakfast club rates.

At the end of each school day, parents are expected to pick up their child(ren) promptly from school or from any clubs they attend. Children who are not collected from school for whatever reason by 3:30pm will be cared for in After School Club. The parent will then be invoiced for this childcare at the usual after school rates.

The Role of the School Staff

The Headteacher has overall responsibility for attendance.

Class teachers complete a register at the beginning of each morning and once during the afternoon session. Marking the attendance registers twice daily is a legal requirement. (The Education (Pupil Registration) (England) Regulations 2006) Teachers mark pupils present, absent or late. Attendance is monitored by the school Inclusion Officer.

It is the responsibility of Park Way Primary School (Inclusion Officer) to ensure:

- Attendance and lateness records are up to date
- If no reason for absence has been provided, parents are contacted on the first day of absence

- Where there has been no communication, letters are sent to parents requesting reasons for absence with a seven day reply deadline before the absence is unauthorised
- The appropriate attendance code is entered into the register (National Attendance Codes)
- Parents informed termly of child's attendance figure

The school follows a stepped approach to attendance and there is a commitment to reward good punctuality and attendance at school.

Timeline of School Action

100%	Children are rewarded for their consistent attendance. This is the minimum expected level of attendance for ALL children.
94% -99.9%	Attendance will be closely monitored. With just a little improvement attendance can reach the minimum expected level. Medical Evidence may be required by the school in order for absences to be authorised.
90%- 93.9%	Parents will be notified and any concerns will be discussed. Parents will be offered support and notified of the consequences of a further decline in attendance. Medical Evidence will be required by the school in order for absences to be authorised. The school will refer these cases to the Local Authority Attendance Service who will work with the school to improve attendance of individuals.
Below 90%	Lack of attendance is a significant concern. Attendance will be monitored daily. Medical Evidence will be required by the school in order for absences to be authorised. Parents and children will be invited to attend a meeting to discuss concerns and any support that can be offered.
Below 90%	(with no improvement) Penalty Notice request. Consultation with KCC attendance service and referral. This may lead to prosecution if there is no improvement subsequently.

Reasons for absence are recorded and retained by the school. When a referral to the Attendance Service is made, the child's Registration Certificate, copies of all letters sent to parents and minutes of any meetings **MUST** be attached to the completed AS1 referral form with any other relevant information.

Lateness

Children may come into class from 8.45am to settle and get organised for the day. At our school the register is taken at 8.55 am and 1.00 pm. Pupils arriving after these times must enter school by the main entrance and report to the community room where their name and reason for lateness will be recorded. From 8.55-9.10 the pupil will be marked as late before registration has closed (Code 'L').

The register will close at 9.10am and 1.05pm. Pupils arriving after the register has closed will be marked as late after registration (Code 'U') and this will count as an unauthorised absence.

Frequent lateness will be discussed with parents and may be referred to the KCC Attendance Service. It can provide grounds for prosecution or Penalty Notice.

Penalty Notice Proceedings for Lateness

- 10 incidents of unauthorised absence including arrival after the registers have closed in a term may lead to a referral to the Attendance Service (AS) for a Penalty Notice Warning Letter
- The Penalty Notice Warning Letter sets out 15 school days during which no unauthorised absence is to be recorded
- If unauthorised absence is recorded during the 15 day period, Penalty Notice(s) will be issued (one per parent per child)
- Where a Penalty Notice is not paid within 28 days of issue, KCC Attendance Service may instigate court proceedings

Authorising Absence

Only the Head Teacher can authorise absence. Where there is doubt, the Head Teacher, on behalf of the governing body, should take a consistent approach. The absence must be unavoidable. The Head Teacher is not obliged to accept a parent's explanation, a letter or telephone message from a parent does not in itself authorise an absence. If absences are not authorised, parents will be notified.

If no explanation is received, absences will not be authorised.

Absence (leave) during term time can only be approved in "exceptional circumstances". The following reasons are examples of absence that will not be authorised:

- Persistent non specific illness e.g. poorly/unwell
- Absence of siblings if one child is ill
- Oversleeping
- Inadequate clothing/uniform
- Confusion over school dates
- Medical/dental appointments of more than half a day without very good reasons
- Child's/family birthday
- Shopping trip
- Family Holidays

Attendance and Lateness

If a new pupil has a history of poor attendance at their previous school, there will be a pre-start attendance meeting held. The school has a 'five-step' approach to monitoring absence and lateness. It will not always be appropriate to progress through all of these steps or even to carry them out in the order listed. Responsible staff will use discretion and discuss each case carefully.

KCC Attendance Service Actions

This may include:

- Attendance Improvement Meeting
- Home visits
- Sign posting to supportive agencies e.g. Child and Adolescent Mental Health Service, Social Services and Family Group Conference Service.
- Fast Track to Prosecution

Penalty Notices for Poor Attendance

- **Penalty Notices are issued in accordance with the Attendance Service Code of Conduct.**
- The Attendance Service issue a warning letter setting out 15 school days during which no unauthorised absence is to be recorded
- If unauthorised absence is recorded during the 15 day period a Penalty Notice will be issued (one per parent per child)

Penalty Notices will be issued in the following circumstances:

- Truancy
- Parentally-condoned absences
- Persistent lateness after the register has closed
- Being present in a public place without reasonable justification during the first 5 days of any fixed term or permanent exclusion.

Where Penalty Notices are imposed, the regulations state that the penalty will be £120 to be paid within 28 days, reduced to £60 if paid within 21 days. Penalty notices are issued to each parent of each child. Failure to pay the penalty in full by the end of the 28 day period may result in prosecution by the Local Authority.

Leave of Absence/Holiday

Parents do not have the automatic right to withdraw their child (ren) from school for a holiday in term time.

From September 2013 the Department for Education have amended the Pupil Registration Regulations, removing the Head Teacher's ability to authorise leave of absence for the purpose of a family holiday.

Section 444 of the Education Act 1996 says that parents are guilty of an offence of failing to secure regular attendance at school unless they can prove that the child was absent:

- **with leave (the school has given permission)**
- **due to sickness or any unavoidable cause (the sickness or unavoidable cause must relate to the child, not the parent)**
- **religious observance**
- **failure by the LA to provide transport**

In law, these are the only acceptable reasons for a child being absent from school.

Leave may only be authorised in "exceptional circumstances" and agreement to each request is at the discretion of the Head Teacher and Governing Body (Education (Pupil Registration) (England) Regulations 2006). Each case will be judged on its merits and the school's decision is final. Once the decision not to authorise leave is taken, it cannot be authorised retrospectively.

Exceptional Circumstances - Family holidays, for whatever reason, cannot be approved, even if the parent is unable to take time off work at any other time. An "exceptional circumstance" would have to be defined as an unavoidable cause eg, a one-off emergency situation which prevents the child from attending school.

Requests for holidays in term time will **not** be authorised.

If the absence is not authorised and the holiday is taken anyway, the case will be referred to the Attendance Service who will issue a Penalty Notice to each parent for each child taken out of school. Failure to pay the penalty in full by the end of the 28 day period will result in prosecution by the Local Authority. One penalty notice is issued to each parent of every child.

Children Missing Education

No child may be removed from the school roll without consultation between the Head Teacher and the Attendance Service. Where a child has left the school and no onward school is identified a "CME" report must be submitted to the Local Authority. The child will remain on the school roll until the school is advised that the child may be removed from the school roll.

I am writing to express my concern over the number of occasions that **NAME** has arrived after the register has been closed. I attach for your information a summary of attendance indicating the days **NAME** was late. (Code U)

At Park Way Primary School the register is taken at 8.55AM and is closed at 9.00AM for the morning session and taken again at 1.00PM and closed at 1.05PM for the afternoon session. Pupils arriving after the register has closed will be marked 'U' which records the absence as unauthorised for that session.

Arriving after the register has closed is seriously disrupting your child's learning and is impacting on their overall attendance.

Persistent late arrival may lead to a referral for a Penalty Notice or a referral to the Education Welfare Officer for further action and possible prosecution.

Dear Parent/Carer

Penalty Notices for Unauthorised Absence

In February 2005, **Kent Local Authority (LA)** introduced Penalty Notices for unauthorised absence from school of at least 10 sessions (5 days) in a current term.

As you can see from the above we are taking this opportunity to remind parents the expectations placed upon schools. Please therefore continue to read the letter and we appreciate your support in this.

The following circumstances will be considered as appropriate reasons for the issuing of Penalty Notices:

- Truancy (including pupils caught on truancy sweeps)
- Parentally-condoned absences
- Unauthorised leave for the purpose of a family holiday in term time
- Delayed return from leave of absence without prior school agreement
- Persistent late arrival at school (after the register has closed)

Penalty Notices are issued **per parent per child**.

On receipt of the Notice, the penalty will be £120 reduced to £60 if paid within 21 days. Failure to pay the penalty in full by the end of the 28 day period may result in prosecution by the LA.

At Park Way Primary School we consider attendance and these legal powers very important, this is why we are bringing it to your attention.

Please ensure that your child attends school regularly and on time.

Our monitoring process has shown that NAME has been absent from school for a total of «Number» unauthorised sessions («Number» days). I refer you to legislation regarding Penalty Notices.

On receipt of the Notice, the penalty will be £120, reduced to £60 if paid within 21 days. Failure to pay the penalty in full at the end of the 28 day period may result in prosecution by the LA.

Please note this is a warning letter that a Penalty Notice could be requested if a total of 10 unauthorised sessions (5 days) are reached this term.

Request for leave during Term-Time **«Child's NAME»**

I have received your request to take **NAMEI** out of school for a family holiday between «Date» and «Date», a total of «Number» school sessions.

From September 2013 the Department for Education has amended the Education (Pupil Registration) (England) Regulations 2006 removing the Head Teacher's ability to authorise leave of absence for a family holiday. Requests for holidays in term-time will **not** be authorised as the Regulations only allow the school to authorise absence (leave) in "exceptional circumstances".

The School's Attendance Policy confirms that:

- agreement to each request is at my discretion, acting in consultation with the Governing Body.
- each case will be judged on its merits
- my decision is final
- leave cannot be authorised retrospectively

I have considered your request but I am writing to confirm that on this occasion the leave will not be authorised. If you decide to take **NAME** out of school I will make a request for a Penalty Notice to be issued.

Or

You failed to apply in advance for permission for **NAME** to be absent from school. As stated above, I am unable to authorise leave retrospectively and I will be making a request for a Penalty Notice to be issued.

Penalty Notices are issued to **each parent of each child** and the amount of the penalty will be £120 to be paid within 28 days, reduced to £60 if paid within 21 days. Failure to pay the penalty in full at the end of the 28 day period may result in prosecution by the Attendance Service.

Traveller Absence

I am writing to say how concerned I am over the number of times NAME has been absent from school. Since «Date», Name has missed «Number» half day sessions achieving an overall attendance rate of «Number»%.

Traveller children have to attend school for 380 sessions (190 days) each year, which is the same for all children and you are at risk of being referred to the Attendance Service if NAME's attendance falls below 90%. I am unable to authorise any absence during term time unless there are exceptional circumstances

If NAME's attendance does not improve and a referral is made to the Attendance Service, you could be prosecuted in the Magistrates' Court unless you can prove that:

- the child has no fixed abode
- because of the nature of your trade or business (work) you have to travel from place to place and your child has attended school as often as possible
- your child has attended for at least 200 sessions in the past 12 months (for children aged 6 years and over)

Traveller Absence

Thank you for contacting me to say that NAME will be absent from school from «Date» as you will be travelling due to your work.

The law allows me to authorise NAME'S absence if your trade or business means that you have to travel from place to place. However, you have not let me know when NAME is likely to return to school. Unless you contact me during the next 10 school days to confirm a date, I will have to refer NAME as a Child Missing Education (CME) to the Local Authority once «he/she» has been absent for 10 consecutive days.

After 20 days absence, the Local Authority will give me permission to take NAME's name off the school roll and you will have to re-apply for a school place when you return.

Traveller Absence
